# Members' News

## **DCMS Comprehensive Spending Review Capital Allocations**

The Department for Culture, Media and Sport (DCMS) has announced capital allocations for its sponsored museums and galleries of £191.4 million over the next three years. The settlement allocates around £108 million to help maintain assets, such as buildings and collections, and the rest to fund new projects.

Allocations include: £22.5 million for the British Museum; £18.2 million for the Natural History Museum; and £13 million for the National Museum of Science and Industry, announced in November when the Prime Minister opened the Launchpad Gallery at the Science Museum, London. Tate Modern will receive a £50 million grant towards its new development to create a new building that will increase the gallery's size by 60%, allowing it to display more of its permanent collection and expand its education programme.

Margaret Hodge, Minister for Culture, Creative Industries & Tourism, said that national museums and galleries are "the envy of the world, setting the highest standards and attracting ever greater numbers of visits." She said: "We are determined to ensure that our national museums continue to thrive as exciting centres of excellence, scholarship and innovation."

The Culture Department will continue to contribute £2 million a year to the DCMS/Wolfson Museum and Galleries Improvement Fund. The Museum of London allocation has been transferred to the Department for Communities and Local Government, as part of the Greater London Authority grant.

#### British Library Funding to Rise in Line with Inflation

The British Library has received an index-linked settlement as part of the Comprehensive Spending Review, in line with that of National Museums. The funding settlement will see its grant-in-aid rise from £92.3 million in 2007-08 to £94.8 million in 2008-09, £97.4 million in 2009-10 and £100 million in 2010-11.

#### **British Library Business and IP Centre to Expand**

The London Development Agency, which provided an initial £1million funding to enhance the British Library's Business & Intellectual Property Centre in 2005, has announced £2.4 million to fund the further development of the facility and its services. #### **Atlantic Worlds Gallery at the National Maritime Museum**

The National Maritime Museum opened Atlantic Worlds, a new permanent gallery, on 30 November, to mark the bicentenary of the 1807 Act for the Abolition of the Slave Trade. The gallery explores the relationship, connections and exchanges between Britain, Africa and the Americas from 1600 to 1850 and looks at the impact and legacy of empire on three continents. It recounts the stories of some of the people involved in the resistance to, and the campaign for the abolition of, the transatlantic slave trade. Paintings, prints, drawings, decorative arts and ethnographic materials are among the 220 objects from the Museum's collections on display in the new gallery.

### The Vault Opens at the Natural History Museum

The Vault, a new permanent gallery at the Natural History Museum opened on 28 November. The Gallery reveals the stories behind rare gems, crystals and metals from around the world. Highlights include The Aurora collection, a group of 296 naturally coloured diamonds, and the Nakhla, a Martian meteorite that fell to earth in Egypt in 1911. ## Medal Room Reopens at the Royal Marines Museum

The refurbished Medal Room at the Royal Marines Museum opened on 28 November. The medals, some of which have never been on display, have been cleaned, re-mounted, re-lit and re-grouped. For the first time, visitors have access to information about all 8400 medals in the collection through state-of-the-art touch-screen 'kiosks'.

## **Airborne Assault Duxford**

Airborne Assault Duxford, a new visitor attraction at Imperial War Museum Duxford, is planned to open in autumn 2008. In the first phase, the Airborne Forces Museum collections will move from Aldershot to a dedicated facility at Duxford, where they will be presented through multi-media and interactive displays. *ParaData*, a digital archive accessible through terminals and online, will provide an interactive history of British Airborne Forces and an illustrated A to Z of operations from 1940.

## New Research into British Collections Highlighted at the National Gallery

The National Inventory Research Project, initiated by the National Gallery, the University of Glasgow and Birkbeck, University of London, aims to address the decline in collection research in UK museums and the lack of publicly accessible information about collections. The Project, which gathers and presents information about Britain's public art collections, started research into European paintings 1200-1900 in 2004. It has now launched an online database of nearly 8,000 paintings from over 200 UK museums and galleries and an exhibition *Discoveries: New Research into British Collections* at the National Gallery, which highlights some of the stories uncovered by the research.

#### National Army Museum Campaign to Save Portrait of General James Wolfe

The National Army Museum has launched an appeal to raise funds to buy a portrait of General James Wolfe, an 18<sup>th</sup> century military hero and victor of the Battle of Quebec - which resulted in the transfer of Canada to the British crown. The Museum has until April 2008 to raise £300,000 to buy the portrait and prevent it being exported. Pledges of over £100,000 have already been secured.

The export of the portrait was temporarily stopped by the MLA Reviewing Committee on the Export of Works of Art and Objects of Cultural Interest, following its sale at auction.

## **National Portrait Gallery Appeal to Buy Portrait of John Fletcher**

The National Portrait Gallery is hoping to raise funds to purchase the only known portrait from the life of Jacobean playwright John Fletcher (1579-1625), which it says "would be a wonderful addition to the National Portrait Gallery's collection of Elizabethan and Jacobean writers."

The Gallery has until 20 January 2008 to raise £218,000 to acquire the portrait, a substantially reduced price following tax remission. The Art Fund has announced a £50,000 grant to help buy the painting. www.npg.org.uk/johnfletcher

## **Current Issues**

#### Launch of Legacy Trust UK

Legacy Trust UK, a new £40 million fund, has been launched to "support a wide range of innovative cultural and sporting activities for all, which celebrate the London 2012 Olympic and Paralympic Games and which will leave a lasting legacy in communities throughout the UK". It will support cultural, educational, healthy, sporting and other charitable activities.

The Trust will distribute funds under the themes: Sport & Wellbeing; Knowledge & Learning; and Arts & Culture, and is committed to achieving UK wide coverage and reaching diverse communities. The Trust plans to support a small number of national programmes, including the UK School Games, the Big Arts Week and the World Festival of Youth Culture, and it will work closely with the London Organising Committee for the Olympic Games and Paralympic Games (LOCOG).

### **Conservative Arts Taskforce Report**

The Conservative Arts Taskforce, an independent group led by Sir John Tusa, has published its findings in a report A New Landscape for the Arts. The report makes a number of recommendations, including:

- Direct grant funding from the Department of Culture for national arts organisations that are regularly funded by Arts Council England, on the same basis as National Museums.
- Amending the designation of certain arts Non Departmental Public Bodies, such as the major National Museums, so that they can operate with greater independence.
- Extending the three-year funding cycle for arts organisations to a five-year period.
- Simplifying tax incentives for giving and introducing more generous tax incentives for philanthropy and life-time gifts, to help increase the amount of private giving to the arts.
- Increasing National Heritage Memorial Fund funding from £10m in 2008 to £50 million annually.
- Moving sport to create a Department of Culture.

The Conservatives will consider the report's findings, which will inform the party's manifesto and arts strategy. #### **Creative Scotland Bill**

Scottish Minister for Culture Linda Fabiani has set out the Scottish Government's plans to establish Creative Scotland to the Scottish Parliament. She said that Creative Scotland would "cultivate and support the best of Scottish arts and creativity". The Minister said that she believed that government "should not arbitrate on artistic decisions", that Creative Scotland would "have a licence from the Government to take risks" and that Scottish Ministers are committed to widening access and participation in culture in Scotland.

The Creative Scotland Bill will be introduced early next year. The Chair and joint board of the Scottish Arts Council and Scottish Screen are developing a plan and infrastructure for Creative Scotland, which will be a Non Departmental Public Body, accountable to Scottish Ministers. The overall budget for culture and Gaelic in Scotland will increase by 16% over the spending review period.

## **Wales Heritage Budget**

On 7 November Welsh Heritage Minister, Rhodri Glyn Thomas unveiled an additional £36 million over the next three years to support One Wales commitments in the Heritage portfolio.

He said: "Creating an environment where Wales' creative potential can develop and flourish is a key priority for this portfolio. We will be working with our partners on the Arts Strategy Board to implement the recommendations of the Stephens Report and a £4.5 million merit pot will be available over the next three years to reward the very best of our companies". The Arts Strategy Board was set up in response to the recommendation in the 2006 Stephens Report to establish a forum to ensure a joined-up approach to the development of arts policy and strategy in Wales.

#### Spoliation Advisory Panel Ruling on Courtauld Institute Rubens Paintings

The Spoliation Advisory Panel has published a Report which concludes that Franz Koenigs, a Dutch art collector, lost possession of three paintings by Sir Peter Paul Rubens, now in the Courtauld Institute of Art, because of business/economic reasons and not because of the actions of the Nazis.

Franz Koenigs gave the paintings to the Lisser and Rosenkranz Bank in 1935 as collateral for a loan. In 1940 the bank went into liquidation. It called in the loan against the paintings and Franz Koenigs chose not to discharge it. The Bank then sold the paintings as it was entitled to do under the loan agreement.

#### Forecasts Show Changing Mix of Overseas Visitors by 2012

Visit London has released forecasts showing how the mix of visitors to London will change by 2012 if current trends continue. They show that the US is expected to remain London's number one market between now and 2012. France and Germany, currently ranked 2 and 3, remain unchanged while Poland, which is currently ranked 9, will rise to 5<sup>th</sup>.

The Japanese market is predicted to fall from ranking 16 to 27. Last year, for the first time, Indian visitors to the capital outspent Japanese visitors, spending £152 million compared to £134 million spent by Japanese visitors. China could rise in ranking from 37 to 18 by 2012 and Turkey is forecast to rise from 31 to 13. corporate.visitlondon.com/press centre/press releases/071109 changing overseas visitors.html

# **Parliamentary Report**

## **Prime Minister's Statement on National Security**

On 14 November the Prime Minister, Gordon Brown, made a statement in the House of Commons on national security, ahead of the publication of the national security strategy.

Discussing the need to deal with "the challenge posed by the terrorist threat" and counter extremism the Prime Minister said: "by emphasising our shared values across communities we can both celebrate and act upon what unites us. This...is a generational challenge that requires sustained work over the long term, through a range of actions in schools, colleges, universities, faith groups and youth clubs, by engaging young people through the media, culture, sport and arts..."

He added: "We will have joint work with the French and German Governments on building an appreciation of the Islamic and Muslim heritage across Britain and Europe. Arts Council England, the Tate Gallery, the Victoria and Albert Museum and the British Library will all be taking forward projects to promote greater understanding".

The Prime Minister also said that companies responsible for crowded places would be given advice on improving resilience against attack and that new guidance would be sent to public venues that will include advice on training staff to be more vigilant. #### **Bills Announced in the Queen's Speech**

The Government's legislative programme, unveiled in the Queen's Speech on 6 November, lists a number of Bills with a cultural dimension, including:

- The draft **Heritage Bill**, expected to be published next year.
- The draft **Cultural Property (Armed Conflict) Bill** which would allow the UK to ratify the 1954 Convention on the Protection of Cultural Property in the Event of Armed Conflict, making it illegal to damage cultural property or trade in cultural property illicitly removed from occupied territory.
- **Dormant Bank and Building Society Accounts Bill**, which would allow the government to use money held in bank and building society accounts which have not been used for 15 years to provide more youth facilities and social investment through the Big Lottery Fund. The bill has had a second reading in the House of Lords.

### **Greater London Authority Act Receives Royal Assent**

Under the Act the Mayor will also gain rights of appointment of board members of the Arts Council England, London; English Sports Council London Regional Sports Board; and MLA London. ## **Parliamentary Questions**

Questions in the Lords about the Cultural Olympiad and Impact of Olympics Spending Overrun on Arts Questions were asked in the Lords about the objectives, structure and funding of the Cultural Olympiad, its main projects and how objectives will be met. Responding for the Government, Lord Davies of Oldham said that funding for the Cultural Olympiad would come from private and public sources: non-departmental public bodies would spend some of their budget on the Cultural Olympiad, LOCOG sponsors are keen to play a part and the Legacy Trust will be an additional source of funding.

Lord Davies added that the Government's legacy action plan, which will explain how the Government will deliver its commitments for the 2012 Olympic Games and Paralympic Games, including Cultural Olympiad projects, as set out in *Our Promise for 2012*, will be published in the next few months.

## International Issues

### Houston Museum of Fine Arts, Lincoln Center Leads in US Donations

According to the Chronicle of Philanthropy's annual Philanthropy 400 survey, which covers 400 of the largest US-based non-profit institutions, the Houston Museum of Fine Arts received \$185.8 million in private donations in 2006, more than any other US arts organisation. The Museum of Modern Art, New York, was second, raising \$133.5 million, followed by The Smithsonian Institution in Washington with \$131.2 million; Boston Museum of Fine Arts with \$130.4 million; the National September 11 Memorial and Museum at the World Trade Center with \$114.8 million; and the Metropolitan Museum of Art with \$108.9 million.

Private support for arts organisations, including libraries, museums and public broadcasting, rose 17.5% from 2005 to \$2.5 billion. Private donations to US education institutions increased 11.3% to \$17.6 billion. www.philanthropy.com/stats/

## **Italy Uses TV Telethon to Fund Restoration**

The Art Newspaper reports that the Italian government held a three-day television telethon in October to appeal for funds for the restoration and protection of seven archaeological and cultural sites, including: Augustus's villa on the Palatine Hill in Rome; a museum for visually impaired people in Ancona; and the Cremona centre for the restoration of antique musical instruments.

Culture minister Francesco Rutelli appeared with actors and opera singers on state broadcasting channel RAI to describe the plight of the country's monuments. By the end of the weekend €2.8 million had been raised against a target of €3.5 million.

## National Museum of Iraq to Reopen

The Art Newspaper reports that two galleries at the National Museum of Iraq in Baghdad are due to reopen at the end of December. The galleries hold large Assyrian and Islamic antiquities, including stone panels from the royal palace at Khorsabad, which present a lower security risk than smaller items. Restoration work on the galleries has been completed by Iraqi contractors, funded by the Italian Ministry of Culture. #### **Undercover Restorers Fix Pantheon Clock**

The Guardian reports that four members of Untergunther, an underground cultural guerrilla movement that aims to restore France's cultural heritage, have been cleared in a French court of causing damage to the Pantheon in Paris, where they secretly repaired an antique clock.

The group told officials once the year-long repair had been completed "so that they would know to wind the clock up so it would still work".
